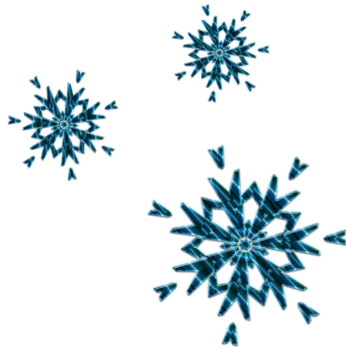

WE HAVE 51 MORE KIDS PLACED IN CARE IN DEC 2017 THEN THAN WE DID IN JAN 2017.

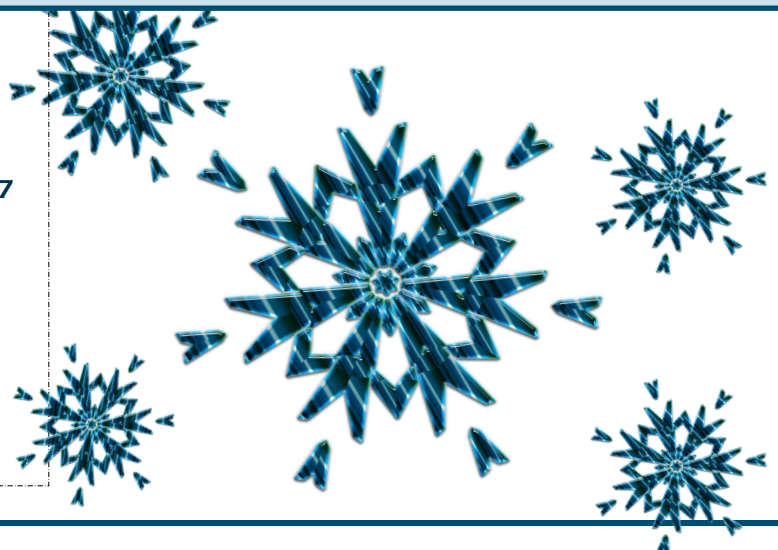
WE HAD 88 KIDS RETURN HOME IN 2017.
